The licensee named above is authorised to sell liquor at the licensed premises described above, in accordance with the Liquor Control Act 1988 ("the Act"). The licensee must comply with all requirements and conditions imposed by the Act, any conditions or authorisations published by notice under section 31 of the Act, and any conditions or requirements set out below. The licence continues in force until surrendered, suspended or cancelled under the Act.

1. EXTENDED TRADING PERMITS

2. CONDITIONS IMPOSED UNDER THE LIQUOR CONTROL ACT 1988

TRADING HOURS - RESTAURANT LICENCE

Unless otherwise varied by a condition on this licence, the permitted trading hours in accordance with section 98F of the Act are at any time except from 3 a.m. to 12 noon on ANZAC Day.

TRADING CONDITIONS - RESTAURANT LICENCE

The licensee is permitted to sell and supply liquor in accordance with the provisions of section 50 of the Act. The sale of packaged liquor for consumption off the licensed premises is prohibited.

ENTERTAINMENT CONDITION

1. The licensee or manager, or an employee or agent of the licensee or manager, shall not -
 - (a) be immodestly or indecently dressed on the licensed premises,
 - (b) take part in, undertake or perform any activity or entertainment on the licensed premises in a lewd or indecent manner,
 - (c) exhibit or show, or cause, suffer or permit to be exhibited or shown, on the licensed premises any classified "R" moving picture or extract therefrom,
 - (d) cause, suffer or permit any person employed, engaged or otherwise contracted to undertake any activity or perform any entertainment on the licensed premises to be immodestly or indecently dressed on the licensed premises, or
 - (e) cause, suffer or permit any person to take part in, undertake or perform any activity or entertainment on the licensed premises in a lewd or indecent manner.
2. In this condition "licensed premises" includes any premises, place or area:-
 - (a) which is appurtenant to the licensed premises, or
 - (b) in respect of which an extended trading permit granted to the licensee is for the time being in force,but does not include any part of the premises which is reserved for the private use of the licensee, manager or employees of the licensee and to which the public does not have access.

APPROVAL OF AGREEMENT

Pursuant to section 104(3) of the Liquor Licensing Act 1988 approval is granted for the licensee to enter into an agreement with Camino Real Pty Ltd, Dahlongea Pty Ltd on the one part and Taylormade (WA) Pty Ltd on the other part.

REGISTERS

The licensee must maintain on the licensed premises the following registers:

1. a register of prescribed incidents that take place on the licensed premises (section 116A of the Act and regulation 18EB of the regulations refer); and
2. a register that records training compliance for all staff (section 103A of the Act and regulation 14AG refer).

These registers must be maintained in a form approved by the Director of Liquor Licensing. The licensee, or an employee or agent of the licensee of the business conducted under the licence shall, at the request of an authorised officer, produce the registers for inspection by that authorised officer.

This licence takes effect from **22 December 2010**.
